STYLE SHEET FOR AUTHORS

Diritto penale contemporaneo – Rivista trimestrale welcomes unedited papers on topics of current interest to the international community of law scholars and practitioners.

The journal publishes articles in Italian, Spanish, English, French, German and Portuguese. Each article must be accompanied by a title and an abstract (limited to 1,000 characters including spaces) in the same language as the submission. It is within the remit of the author to add a subtitle, again in the same language as the article. The editorial board will, in agreement with the author, provide a translation in Italian, Spanish and English of the title, any subtitle and the abstract. Please indicate authorship and an email address to which readers can send comments. In the acknowledgements please be sure to thank all those who have contributed any considerations culminating in the final work.

The paper must be divided into numbered paragraphs (1, 2, 3 etc.) each with a separate subheading. It is at the discretion of the author to breakdown the text further into numbered subparagraphs (1.1, 1.2, 1.3 etc.; 2.1, 2.2., 2.3 etc.), again each with a separate subheading. Italics must be used throughout for words that are in a language different (including Latin) to that of the article. Italics may likewise be used to give emphasis to certain expressions or words. Bold font is not permitted.

At the end of each paper, a full reference list of all sources cited, in alphabetical order according to the (first) author's name, must be included. In the footnotes, please only use **abbreviated references** indicating; i) the surname or surnames of the author (in SMALL CAPS), followed by the initial of any forenames only where more than one author cited shares the same surname; ii) the year of publication of the work (followed by a letter in lowercase in alphabetical order where more than one article is cited by the same author in the same year); iii) the page or pages cited. In the case of works with two authors, the surnames of both authors joined by 'and' should be indicated in the footnotes. Meanwhile, in the case of works with three or more authors, simply indicate the first author followed by "et al.".

Footnote examples:

DWORKIN (1986), p. 228

DWORKIN (1986), pp. 228-240

If both Ronald Dworkin and Gerald Dworkin have their works cited in the paper, the reference will read as follows:

DWORKIN R. (1986), p. 228

If two or more works are cited by the same author and published in the same year e.g. Ronald Dworkin, 1986, the reference will read as follows:

DWORKIN (1986a), p. 228

In the case of co-authored works, the reference will read as follows:

DWORKIN R. and DWORKIN G. (1986), p. 228

DWORKIN *et al.* (1986), p. 228

In the **full reference list** at the end of the submission complete bibliographical information relating to each entry should be shown as follows:

- 1. Author's surname or surnames (in SMALL CAPS) and forename (in roman type); in the case of two authors, separate surnames with "and"; in the case of three or more authors, use a comma between surnames.
- 2. Year of publication (in parentheses). In the case of a number of publications by the same author in the same year, the year of the first publication will be followed by a small letter "a"; the year of the second will be followed by a small letter "b"; etc.
- 3. Title of the entry:
- for a book, please cite the complete title in *italics*
- for a chapter of a collective volume, please cite the complete title of the work which must be in double quotation marks and in roman type
- for an article from a journal cite the complete title of the article in double quotation marks and in roman type
- 4. Place of publication
- for a book: town and publisher (in parentheses)

- for a chapter of a collective volume; i) surname or surnames of the editor; ii) name or names of the editor (in the case of more than one editor please apply the terms supra, 3) followed by "eds." in parentheses; iii) title of the volume (in italics); iv) town and publisher (in parentheses); v) first page and last page of the chapter;
- for an article from a journal; i) name of the journal in full (in *italics*); ii) volume and/or issue (if it does not coincide with the year, and if the page is not sufficient to identify the article); iii) first page and last page of the article.

Likewise for any reference to **legislation**, please apply the standards used in the country or in the international organisation that the citation refers to.
